The Northeast Agenda is a collaboration between the Association of Northeast Extension Directors (NEED) and the Northeastern Regional Association of State Agricultural Experiment Station Directors (NERA).

It identifies challenges and opportunities for the Northeast region's Land-grant programs as they work together to ensure a regenerative, livable, and vibrant Northeast United States.

The Northeast Agenda is intended to inform policy responses and actions and demonstrate how Agricultural Experiment Stations and Cooperative Extension can support all Northeastern Region communities to thrive.

Unique Attributes and Common Critical Concerns

In the context of NEED and NERA, the Northeast United States includes Connecticut, Delaware, the District of Columbia, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, and West Virginia.

The Northeast covers just 6% of the mainland United States but is home to 20% of the US population and contributes 24% of the U.S. GDP from industries as diverse as farming, fishing, health care, manufacturing, education, and technology. Its landscape includes farmland, shorelines and rivers, forests, mountains, and major urban centers as well as rural communities. Its diverse population is a microcosm of the country's overall ethnic and racial diversity.

Nevertheless, each state, each community, and each industry in the Northeast shares four critical concerns: water (quality and quantity), climate change, shifting population growth trends, and science literacy.
